

### MCNABB CENTER AWARDED CHILDREN'S CSU GRANT, EXPANDS CHILD CRISIS CONTINUUM

The McNabb Center will be working with East Tennessee Children's Hospital to develop a children's crisis stabilization unit (CSU) at Children's Hospital. The program, which is the first of its kind in Tennessee, is funded by a \$5 million Substance Abuse and Mental Health Services Agency (SAMHSA) grant to create a crisis continuum of care for children.

“This CSU will help strengthen families who are dealing with a crisis situation and provide the best opportunity to keep those families together,” said Jerry Vagnier, McNabb Center CEO. “Helping our region's children address acute mental health challenges, and providing them with extended care following their moment of crisis, will give families the support they need as they navigate these challenges.”

### KNOXVILLE LEADERS, GOV. LEE MEET, DISCUSS PSYCHIATRIC URGENT CARE

On Nov. 1, 2021 Jerry Vagnier, McNabb Center CEO, and a team of Knoxville leaders met with Governor Bill Lee, Commissioner Marie Williams, TDMHSAS and Deputy Director Stephen Smith, TennCare to make the case for a new Urgent Psychiatric Facility in Knoxville. This regional facility would provide an alternative to the general medical hospital emergency room for adults in psychiatric crisis.

The city and county mayors articulated the need that exists in our community and the stress the current system has on our hospitals. The hospitals amplified the message with data from their experience. Our community partners described an innovative pilot program that would improve access to psychiatric care

and initiate treatment immediately. This unique setting would provide for a physical examination and medical clearance prior to the patient seeing a behavioral health specialist. Being able to triage, assess, treat, refer and coordinate aftercare would be critical components of this pilot project. This pilot is modeled after psychiatric emergency departments in other parts of our country.

The request is to partner with the state for 50 percent capital investment in a facility and ongoing operational support to demonstrate the program's effectiveness. The goal is to reduce the incidence of adults seeking psychiatric help at area emergency departments as well as provide

alternatives to psychiatric hospitalization. There is good clinical reason to believe this service would help stabilize adults in crisis and get them to the level of care they need timely.

# MCNABB STAFF, PROGRAMS HONORED AT TAMHO AWARDS

The McNabb Center was proud to accept several awards at the Tennessee Association of Mental Health Organizations (TAMHO) annual conference in December.

Candace Allen, senior director of adult intensive mental health services, was honored with the Distinguished Service Award, which recognizes an individual for their extraordinary and long-standing dedication and service. Candace has spent more than 40 extraordinary years changing the face of behavioral health care and serving the community.

Under her leadership, the McNabb Center expanded its school-based services, implemented the area's first and only Program for Assertive Community Treatment and created the Crisis Stabilization Unit. Candace has been instrumental in bringing Crisis Intervention Team (CIT) training to local law enforcement and ensuring the development of the Behavioral Health Urgent Care Center.

The McNabb Center is fortunate to benefit from Candace's knowledge and compassion.

The McNabb Center was also recognized with TAMHO's Outreach and Engagement Award for the suite of services the Center provides through partnerships with the University of Tennessee Medical Center (UTMC) and East Tennessee Children's Hospital.

In order to fill gaps in mental health care and substance use treatment, the McNabb Center develops community partnerships that benefit the people served. The Center established an Embedded Psychiatry program in 2019, which provides a McNabb Center psychiatrist directly in the UTMC and Children's Hospital emergency rooms to assist with evaluations and consultations to help ensure patients receive access to treatment resources.

The Center's Hope United program at UTMC connects individuals struggling with substance use disorders with community recovery resources. The McNabb Center's Sexual Assault Center of East Tennessee has long-partnered with UTMC to provide forensic nursing to sexual assault crime victims.

Finally, the McNabb Center has become the hospital's preferred provider for behavioral health concerns. The vulnerable populations served through these programs have continued to receive care even in the midst of an enormous public health crisis.

Jerry Vagnier, CEO, and Paula Hudson, senior director of corporate compliance, were honored with President's Awards for their service to the TAMHO organization.

## MCNABB CENTER OPENS NEW CRISIS STABILIZATION UNIT IN HAMBLLEN COUNTY

The McNabb Center celebrated the ribbon cutting of its new Crisis Stabilization Unit (CSU) in Hamblen County. The 15-bed unit will offer care 24 hours a day, seven days a week for those who are 18 or older and facing a behavioral health crisis.

“The goal of this unit is to divert people, when appropriate, from psychiatric hospitalization,” said Sharon Reid, McNabb Center’s senior director of Hamblen County services. “We believe individuals are best served within their natural support system in their own communities, and the CSU supports this philosophy.”

The CSU serves the Tennessee Department of Mental Health & Substance Abuse Services (TDMHSAS) Regions 1 and 2, which include Anderson, Campbell, Claiborne, Cocke, Grainger, Hamblen, Hancock, Hawkins, Jefferson and Union counties.

TDMHSAS Commissioner Marie Williams attended the ribbon cutting and spoke about the importance of having this service in the Lakeway Area.

This project is funded through the Tennessee Department of Mental Health & Substance Abuse Services (TDMHSAS).



## MOBILE CLINIC RECOGNIZED BY RURAL HEALTH ASSOCIATION OF TENNESSEE

McNabb Center’s Mobile Health Clinic, which serves Cocke, Hancock, Grainger, Claiborne and Jefferson counties was recognized with the Exemplary Project award at the Rural Health Association of Tennessee’s annual conference. The award honors an organization or group that has successfully developed a unique program or project that advances rural health. The Mobile Health Clinic, which is part of Project Rural Recovery and funded by the Tennessee Department of Mental Health and Substance Abuse Services, screens for mental health, substance use and chronic health conditions and provides mental health and substance use treatment.



Shellie Hall, senior director of Sevier, Blount and Cocke counties, and Kate Orem, Cocke County services coordinator, attended the conference and accepted the award on behalf of the McNabb Center. Buffalo Valley, which operates a Project Rural Recovery clinic in middle Tennessee, received the award as well.

## RACHEL LOVEDAY RECEIVES TWO AWARDS AT CPRS ANNUAL CONFERENCE

Rachel Loveday, Hope United team leader, received two awards at the 2021 Certified Peer Recovery Specialist Conference. She was recognized with the Patsy Cronk Mentor of the Year Award, which is presented to the CPRS who demonstrates exceptional role modeling and mentoring to other peer specialists. In addition, Rachel received the Advocate of Peer Recovery Service — Individual award for her work advocating for peer recovery services to empower those living in Tennessee with a mental health and/or substance use disorder.

Rachel oversees the McNabb Center's Hope United program, which connects individuals struggling with substance use disorder with recovery resources. The program is funded by the United Health Foundation and engages individuals who enter the University of Tennessee Medical Center due to overdose.

## CHILD CRISIS, CONT'D FROM 1

Children who enter the CSU will receive behavioral health treatment including therapy, medication and other services to help them work through their crisis. Clinicians will determine how long a child can stay in the CSU based upon their needs.

“Our vision is to lead the way to healthy children, which must include leading the way to improved mental and behavioral health care and access,” said Matt Schaefer, Children's Hospital president and CEO. “Unfortunately, visits to our Emergency Department for depression, anxiety and suicidal ideation have escalated to alarming proportions, with behavioral health visits growing by more than 60% since 2020 to more than 1,500 annual visits.”

The goal of the CSU is to provide a safe place to address the needs of children facing a mental health crisis while diverting the child from psychiatric hospitalization. Families will be able to access CSU services through the emergency department or through a Mobile Crisis Unit.

“Our motto for our statewide network of crisis services is ‘right measurement, right place, right time.’ Having this developmentally appropriate alternative to inpatient hospitalization for children and youth combined with the life-changing interventions offered by the amazing staff of the McNabb Center will have a positive impact for generations to come,” said Commissioner Marie Williams, LCSW, of the Tennessee Department of Mental Health & Substance Abuse Services.

Once the child is stabilized, they can receive intensive community-based treatment through the McNabb Center. The CSU is one piece of a comprehensive continuum of care to address the

increasing mental health crisis in children and teens in East Tennessee.

In addition to the SAMHSA grant, the McNabb Center was awarded a Community Mental Health Services Block Grant to address a gap in children's crisis services in the Knoxville area.



The Center established a Family Walk-In Center that helps children experiencing a mental health crisis receive intensive services within the community, while avoiding hospitalization.

The Family Walk-In Center will identify children in need through the Mobile Crisis Unit, referrals from area hospitals and other community agencies and organizations. In addition, families can self-refer to this program.

The Family Walk-In Center is open seven days a week from 8 a.m. - 8 p.m. and is located at 5645 Merchants Center Blvd. in Knoxville.

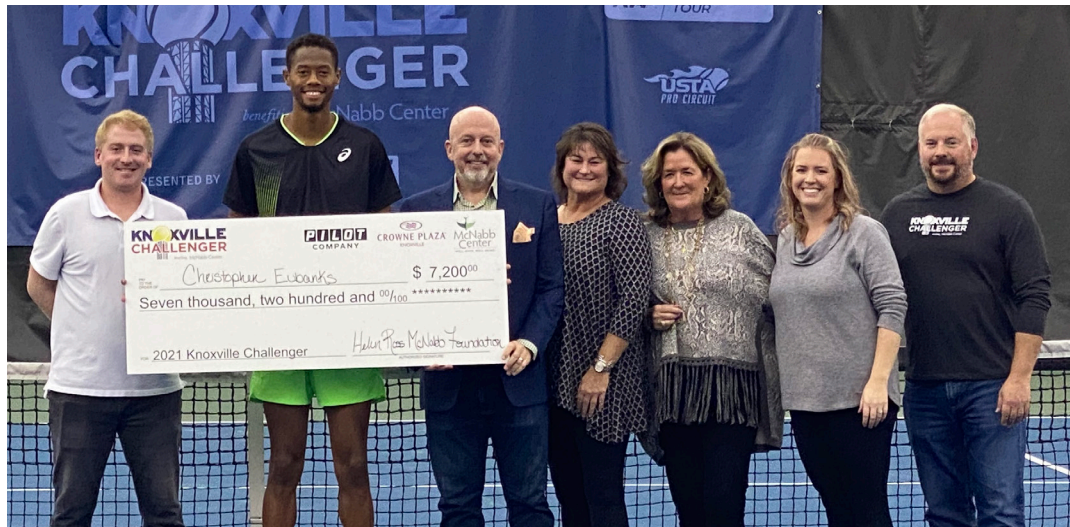
Together, the CSU and Family Walk-In Center expand the McNabb Center's full continuum of children and youth services. The CSU is expected to open in early 2022.
